Healing Touch Certificate Program™

The HTI Healing Touch Certificate Program™ is a multi-level course of study in energy-based therapy that moves from beginning to advanced practitioner and is complementary to health care. The program incorporates a variety of energy-based modalities that are sequenced in Levels 1 through 5, allowing participants to progress from beginner to practitioner. Students receive a certificate of completion at each level. 7. Report receiving other healing modalities through ten documented experiences from other practitioners.
8. Discuss Healing Touch research and implications for practice.
9. Describe Certification as a Healing Touch Practitioner
10. Demonstrate application of HTI's Standards of Practice and Code of Ethics within one's Healing Touch practice.
